LITTLE CLACTON PARISH COUNCIL MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD AT THE YOUTH AND COMMUNITY CENTRE ON MONDAY 2 FEBRUARY 2009 AT 7.30 PM

ITEMS RAISED BY RESIDENTS

Application for a toilet block behind Holland Road was raised but the Parish Council has no information of such an application. Councillors will enquire about this.

Residents at 80 Holland Road complained that the application for composting area between 58 and 64 Holland Road was agreed but the site seems to have been moved outside their property.

Public footpath has been cut off in Homing Road. It was agreed to write to ECC about this. Another bridle way is causing difficulties. Cllr Skeels has asked for dog litter bins. **APOLOGIES**

Apologies for absence were received from Cllrs Carter, Dass and Ward.

MINUTES OF THE MEETING HELD ON 5 JANUARY 2009

A resident had asked for Minutes to be available other than on the website. It was agreed that approved Minutes be placed on the notice boards.

WORKING PARTY REPORTS

Maintenance and Services

Cllr Watson reported that we are still awaiting details from BT regarding Parish Fields road entrance gates. He is waiting for suitable weather to complete the work the memorial area. He has been given 400 daffodil bulbs from a local resident in memory of her mother, Mrs M Clark, to be planted around the memorial trees. Letter of thanks has been sent to the donor.

'Plough Corner' signs have been attached to three sides of the flower tub on the corner of Harwich Road.

Replacement bollards have been received and the order for installation has been made. In the mean time, a couple of bollard tops have appeared and have been positioned over the damaged units. No idea where they have come from and unfortunately, they are not the same colour as our street furniture. They will be recovered and placed in store. Lighting Columns – entrance road at Plough Corner

Although we were told they had been disconnected from ECC supply, the column alongside the Community building still has a live cable crossing the road at its base. All the columns have been removed and we have concreted over the cable complete with a warning plate.

Cllr Watson proposed that a letter of thanks be sent to the Methodist Church, together with a cheque for £35, for allowing us to use their electricity for the Christmas lights. This was agreed.

TDC has not offered the normal tree grant programme this year they are involved in their own scheme of planting in various public areas throughout the district. Cllr Watson would like to continue with our annual planting programme by concentrating on the area in front of the ATC fence. He has prepared a planting schedule for four more flowering trees and a range of shrubs providing a decorative screen along the fence and building. The cost to cultivate, provide top soil, trees and shrubs and labour to plant is £446.00.

This was proposed by Cllr Watson, seconded by Cllr Wood and agreed.

The alterations to the all weather playing area lights have been completed allowing the lights to be turned on and off to suit requirements as opposed to being controlled by a slot meter and timer. A report does advise us that the installation is quite old and the lanterns have deteriorated. Modern units would be more effective and much more efficient to run. The electrical test and inspection on the football flood lights has shown up several serious problems which would be very expensive to rectify. Cllr Watson has discussed this with the Parish Fields Chairman and as there is currently very little call on the use of this facility, no further action will be taken.

A section of kerbs, directly opposite the Community building have been broken resulting in vehicles running on to the grass. To excavate, supply materials and lay new kerbs and clear away spoil would be £400.00.

It was proposed by Cllr Watson, seconded by Cllr De Vaux Balbirnie and agreed that this work be undertaken.

Street Lighting No report

Footpaths

A resident from Homing Road area has informed us that the footpath connecting The Street and Homing Road has been closed to access by a fence being erected across the footpath. It appears that the owners of the land on one side of the path have now purchased the land on the other side of the path. They keep horses and to secure the plot they have fenced in the combined areas without any means of passage to pedestrians ECC to be advised of the situation.

Planning and Development

Cllr Wood reported on the following planning application:

09/00026/FUL Change of use application to relocate displaced caravan pitches from Firs Park on adjacent land with 47 additional pitches in a low density informal layout including the creation of a lake, landscaping and tree and woodland planting allied to the proposed upgrading and restructuring of the existing park (new informal low density layout and landscaping) at Firs Caravan Park, 29-31 London Road

The Chairman closed the meeting at 8.20pm to allow residents to voice their concerns and reconvened at 8.30 pm

LITTLE CLACTON PARISH FIELDS AND YOUTH AND COMMUNITY CENTRE

Cllr Cutting reported that pitch hire bookings have again been affected by adverse weather conditions, although there was a full programme over the last weekend. It has now been agreed that the Youth Bus will attend on a weekly basis for the next 12 weeks. Planning continues for the Home and Garden shown and the Classic Car Show this summer. The Car Boot season will start on 14 June and continue until 11 October.` The Chairman plans for a rather adventurous Garden Show in the village, with bands, kite flying and stalls. Provision must be made for possible adverse weather and some of the stalls etc must be under cover. The hire of a marquee would be at least £800. Following consideration of the matter, it is proposed that the Parish Field Committee and the Parish Council combine together in order to buy some very large party tents at £199.99 each.

It was proposed by the Chairman, seconded by Cllr Watson and agreed that the Parish Council set aside £1,000 to purchase at least four units. VILLAGE HALL

Cllr Dunnett reported that the hall is nearly fully booked on weekdays and has a new venture – dog training.
