- (b) Highway Matters. Cllr Watson said that he had received numerous telephone calls asking why the pavements have not been gritted as they had been in years past and now the Council tax is so much higher, nothing is done. He said that he had explained that gritting is the responsibility of the County Council and we have no say in the matter of the roads to be gritted.

- (e) Youth and Community Building Extension below ground work was completed before Christmas together with some drainage alterations. There is to be a site meeting to finalise the toilet, kitchen and decoration schedules.
