LITTLE CLACTON PARISH COUNCIL MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD AT THE YOUTH AND COMMUNITY CENTRE ON MONDAY, 7 JUNE 2010 AT 7.30 PM

There were 5 residents and PCSO Barnes present.

ITEMS RAISED BY RESIDENTS

Residents were concerned at the road traffic problems between Little Clacton Road and St Osyth Road West with heavy congestion and near accidents. It was agreed to communicate with County Highways and Tendring District Council to seek a resolution. It was suggested by PCSO Barnes that we should email Bob Sharman of the local police regarding the speed of the traffic.

APOLOGIES

Apologies for absence was received from Cllrs Leatherdale and Ward.

MINUTES OF MEETING HELD ON 10 MAY 2010

These were approved and signed by the Chairman following the addition of a final paragraph to the item under Planning Applications – 10/00427/FUL to read "A copy of the intended response to this application was given to each Councillor to read because of its complexity. The intended response was based on the list of objections previously agreed by the Council when considering two earlier applications for the same location..

MATTERS ARISING

(a) Cllr Watson has taken the time to go back and follow the trail of all three applications for the Firs Caravan Park proposed development and whilst appreciating that time has now passed he found one area which the Council did not clarify clearly.

At the Parish Council meeting on 8 December 2009 regarding the second application (09/01170FUL – Firs Park) during an adjournment when considering this application, the Chairman suggested a compromise, where the proposed development extended straight down beyond the existing site to the old pig unit and the area of the application affecting the 'green wedge' would be allocation as the open space amenity area. Following a discussion period the Chairman proposed and Cllr Watson seconded this compromise but the motion failed and the Council then voted by a majority to lodge an objection on the proposed development on the same ground as listed for the previous application."

Cllr Watson asked the approval of the Council for this statement to be recorded in the current meeting minutes with a cross reference to the Parish Council meeting Minutes of 8 December 2009. This was seconded by Cllr Wood and agreed.

(b) Thursday Lunch Club – there is to be a meeting of the Village Hall Committee to discuss this matter and it was agreed to defer consideration until further information is available but to continue to support the club.

MATTERS BROUGHT FORWARD

- (a) Internet nothing to report
- (b) Highway Matters. pothole in Harwich Road has been reported to County Highways and will be dealt with shortly
- (c) Affordable Housing Chairman closed the meeting from 8.20-8.23 to allow residents to make their comments. In view of the 200 houses being built on the boundary of Little Clacton with Clacton on Sea, what would be the position regarding our affordable houses What is your perception in this event. Meeting closed from 8.24-8.27. The Chairman explained the situation regarding the site. He closed the meeting again from 8.35 to 8.40 to allow Cllr Cossens to take part in the discussion on housing for the future.
- (d) Parish Archives nothing to report
- (e) Youth and Community Building Extension Cllr Watson reported that at the last site meeting the contractor advised us that completion would a further 2/3 weeks bringing completion near to the end of June. As you can see in here the carpet is down, the light fittings completed and the alterations in the hall almost finished. The decoration is the next item, it is the wrong way round but we have had to work around outstanding bookings and the contractors work rate. In the extension the decoration is well on the way, next it will be laying the floor coverings and with these laid the toilets and kitchen can be completed and the heating and water system tested. It is hoped that meanwhile external work to the drainage, paving etc will be completed.
- (f) Local Council Insurance we have received a very favourable quotation from a group called Suffolk Acre who specialise in local authority insurance. Comparing 'like for like' valuations , the new insurer's quotation was over £1,350 lower than our current insurers. We have reviewed the Parish Council assets increasing the valuations where appropriate and included new additions ie this building extension. With the inclusion of the higher asset valuations it has resulted in an annual saving of £1,300.05. We have also taken up the option of a three year period of insurance which ensures that there will be no increase in the premiums for that period subject to asset values remaining the same.

POLICE/CRIME PREVENTION

PCSO Barnes reported on the crime incidents during May which included obstruction in Harwich Road (football tournament); two dogs attacked a child on Firs Caravan Park and one dog running loose in Weeley Road; car fire in St Osyth Road East (stolen); theft from motor vehicles in Holland Road (number plates) St Osyth Road East and Tan Lane (bull bars stolen); problem with parents at Engaines School; theft from Edward Close (statue taken from garden) and a cheque from Meadowview Park; three nuisance problems in Meadowview Park; Vehicle in dangerous position in Holland Road; male acting suspiciously in Amerells Road; theft of a motor vehicle in St Osyth Road West; an assault at the Lodge in Harwich Road; burglary in Holland Road; 10 missing persons at the Lodge in Harwich Road and a road traffic collision in Holland Road. WORKING PARTY REPORTS **Maintenance and Services**

Cllr Watson reported the signs approved by the Council at the last meeting are on order as is the replacement of the seat and base on the triangle in Harwich Road. A collection of old brackets, signs and non working lights have been removed from the fascia on the south end of the Youth and Community building and the rotted timber boards replaced in uPVC.

During recent weeks we have been attending to electrical services to various areas around the complex, for example, disconnecting and removing the cables across the field which supplied power to the old containers, replacing circuit breakers, sockets etc to provide power supplies to external locations and bring the installation up to current standards. On completion of the work, circuits will be tested to enable the annual NICEIC and minor works certificates to be issued.
