MATTERS BROUGHT FORWARD

(a) Internet - Cllr Bellamy reported that agreement has been made with Bendale Web Design for the layout of the revised Parish Council website which satisfies all our requirements without incurring too high a cost. The design is deliberately simple and will show a constant title bar at the top and a constant menu on the left. Content will change in the main window when called up from the menu. The menu now covers all aspects of the Council's activities including meetings, membership, initiatives, Statutory Framework and Finances. The menu also provides information regarding village life in general including details of the facilities available to residents. The new website has been designed to enable new information to be incorporated as and when necessary and all organisations are asked to ensure that the details shown are kept up to date.

The cost for the new site, which will be 34 pages, will be £644 and can be implemented without delay.

It was proposed by Cllr Cutting, seconded by Cllr De Vaux Balbirnie and agreed that the Parish Council go ahead with the new website.

- (b) Highway Matters Cllr Watson reported he had been advised by Cllr Skeels that the footpath along Harwich Road has been cleared of soil. Some Councillors disputed that this had been cleared adequately.
- (c) Affordable Housing the matter is on hold at present.
- (d) Parish Archives some items have been returned
- (e) Youth and Community Building Extension Cllr Watson reported that there has been no further contact from the architect since his own snagging visit back at the end of June. He has been in contact with the contractors to enable several items to be resolved enabling the project to the finalised.

It has been agreed to hold an official opening for a range of guests on Saturday, 16 October 2010 at 12.00 noon.

POLICE/CRIME PREVENTION

PCSO Barnes reported on the various incidents in Little Clacton during August. These included 35 missing persons from The Lodge, loud music in Feverills Road, several incidence of suspicious circumstances and burglaries, an RTC in Holland Road with injury. The Apple Tree has closed down.

Several members mentioned the cars for sale in the roads but were advised this was a matter for TDC.

WORKING PARTY REPORTS

Maintenance and Services

Cllr Watson reported that the contracted maintenance works, grass cutting etc have continued during the month. An additional key has been issued to the local farmer to open the second leaf of the Parish Fields road entrance gates. This facility would be required in the event that he needed access for exceptionally wide piece of equipment (more than 12ft).

Following up on an enquiry from a resident in The Street regarding a nearby front grass area being hard cored over and used for parking, Cllr Watson contacted the ECC as this area comes under their control and they are investigating possible land encroachment. He has also been asked what can be done to stop cars and caravans being parked on the verge and within the road markings around Church corner. This is not only unsightly but makes the slip road section from St Osyth Road unusable and pedestrians must go down the road towards the school to cross the road. It was agreed to write to the owner of these vehicles.

Street Lights - Cllr Ward reported that May Gurney have informed her that some of the cabling to the lights in Holland Road need replacing, luckily at no cost to the

Parish Council. She has reported a light out in Holland Road as well as a light in Tan Lane. The one in Tan Lane was on the list for the last lot of repairs so she is seeking an explanation.

Little Clacton Parish Fields And Youth And Community Centre

Cllr Bellamy reported that the Car Boot season continues and the new football season has commenced. The next Classic Car Show will be held on Saturday, 18 September.

The Youth and Community Hall is still being used regularly for band practices and we hope, shortly, to be in a position to advertise the hall for functions and regular club meetings etc. The seating to the Bandstand has now been replaced following the damage reported last month.

VILLAGE HALL

Cllr Dunnett reported a fairly quiet period. There is to be function on 18 September at West View, Batemans Lane for the village hall.

Playground equipment - temporary measures carried out, some repairs undertaken by the groundsman and his brother (the Smith-Dayes). It is still in use.

The school have a new pre-fabricated classroom and their only access is from the back of the village hall and the field. We have an extended car park without cost to

the hall, from the contractors Part of the hedge has been removed during the work being undertaken.
