## MATTERS BROUGHT FORWARD

- (a) Highway Matters Following the very unsatisfactory reply from ECC Highways regarding traffic in Holland Road, Cllr Smith agreed to contact the local business, Telstar Nurseries, to see if they would support the Parish Council in its attempts to reduce the speed limit. He also agreed to speak with a member of the staff at the electricity sub-station.
- (b) Affordable Housing still in abeyance (pending LDF)
- (c) Parish Archives Cllr Watson reported that a further session is needed to clear up the remaining paperwork and a skip will be ordered to complete the final clearance. The new laptop and printer have been set up and the fax machine is on line. The Parish Council paperwork heading now needs modifying to include the new office and the business and finance team will advise when this has been agreed. Our insurers have been advised of the increased value of our office equipment and have altered the schedule and advised us of the small additional premium cost.
- (d) Youth and Community Building Extension Cllr Watson said that now the festive season is over, arrangements will be made to obtain a copy of the final draft account followed by a meeting with the architect and contractor.
- (e) LDF The Chairman reported that he had spoken with Mr Gary Ashby (TDC planning) and discovered that they have no intention of speaking further with the Parish Council or residents on the proposals unless the completed consultations rendered any of the declared policies unsafe. The Chairman reminded RTDC of the declared intention in the LDF for further consultations and that he wished to call a public parish meeting on the final submission. The Chairman asked for a copy of the final submission to enable the Parish Council and parish to consider and it was agreed that the

Parish Council can be part of the loop. The Chairman asked when these will be available but received no satisfactory reply. N The Chairman will contact TDC in mid-February to see the present position. It was agreed to write to TDC confirming the Chairman's telephone conversation with Mr Ashby that the Parish Council will have a copy of the draft proposals prior to their being dealt with by the Inspector..
