New Standing Orders –The Chairman has gone through the revised 2013 version of the Tendring District Council Members Code of Conduct document and proposed they are adopted for Little Clacton Parish Council with the following amendments:

PART 1 INTRODUCTION

Item 2 When does the code apply?

- 2.1 In this Code "meeting" means any meeting of:
- (a) Little Clacton Parish Council
- (b) Elected and Co-opted Members
- (c) Any of the Working Parties or Groups
- (d) Informal meetings with other members and/or Officers relating to the discharge of the Councils functions.

Part 2 MEMBERS INTERESTS

Section 4; 5; 6; 7; 8; 9 & 10

Disclosure of Interests

We accept, support and will work within the conditions specified in these sections and sub sections and **I propose** to nominate the Parish Clerk as the Parish Council's Monitoring Officer.

Guidelines for the 'Disclosure of Interests' at meetings:-

First and before any discussion on an item placed before the Council you must always disclose if you have an interest – whether or not such an interest is registered on your Register of Interests.

In general it is required that following your declaration of interest you can be asked to leave the meeting during the discussion on the item being considered by members. With any form of Pecuniary Interests, the member should always withdraw from the meeting.

However, if the declared interest is non pecuniary – a general interest – the member should leave the meeting immediately after making their representations and before the business is under consideration, unless they have obtained the dispensation from the monitoring Officer. Dispensation can be sought by applying to the Monitoring Officer a minimum of 48 hours before the meeting and if granted, it is at the discretion of the Monitoring Officer. IF you are permitted to stay in the meeting place you are not permitted to participate in any further discussion or participate in any vote on the matter under consideration at the meeting.

In other words, a member who has declared an interest, can ask the Monitoring Officer to consider if they can stay at the meeting during the discussion and vote.

The Monitoring Officer must consider in their judgement what, if any, effect or influence this would have on the discussion or the result of the business in hand.

The **Chairman proposed** that we agree to adopt, in principal, the revised Tendring District Council 'Members Code of Conduct' with the above local variations.

Seconder: Councillor J Dunnett. - Agreed by all.

We will now write to TDC and confirm our adoption of the document as from our meeting on April 7th 2014.
