Whilst this large plot of land is in the Local plan and therefore will always be built on the Parish of Little Clacton would strongly wish to be included in the discussions and agreements of this applications due to the huge impact on the village. We would remind the Planning team that Little Clacton already has a Primary school, open space and play area that all require a boost of funds to maintain and upgrade. A pelican crossing outside the village hall with permission but needing funds to complete (currently let down by promised monies). Highways that would be used by residents and customers of this new developments which require repairs and huge upgrade for drainage issues. Holland Road already has issues with speeding and receives regular volunteer speedwatch visits with huge results and would benefit from traffic calming measures etc.

We would ask for very firm conditions to be placed on the application to include:

- -A phased building schedule which makes the erection of the school, community building and retail units compulsory. i.e. build 160 bungalow, then school, then care home, then the community building and finish with the 700 dwellings etc.
- -Access to the large site is considered in detail. At present only two access point are shown for the whole site, one of these bottlenecking through the other planning application site. Both exits will feed into the traffic flow on Holland Road and Thorpe Road which we feel would be detrimental to the Village could not another access point be considered towards Telford Road /Stephenson Rd forcing traffic flow along Centenary Way. Amendments by Highways on Roundabout Thorpe Centenary Way which would prevent Traffic being able to turn right into Thorpe Rd with better signage directing traffic towards the A133.

-Early years & childcare facility is not shown on the plan. We would ask for realistic consideration to be taken for this to be a completely separate facility to the school. As we are all aware a nursery attached to a school normally becomes a Preschool which only taking children from the age of three years old. The indication of a 56 place would support this theory based on the 1:8 ration regards Ofsted for the above three years age group requirements. This would therefore leave no support for the parents of all the children under three years old.
