Planning

To consider the planning applications received from Tendring District Council Councillor J Taylor read out the comments made by the Planning Group on the applications listed below.

23/00378/OUT - Land West of Homing Road - Outline Planning Application (all matters reserved) for the erection of four dwellings on an infill site.

This small site sits just outside of our the settlement boundary and we run the risk of the creeping developments extension of the boundary becoming unlimiting. The boundary is in place for a reason.

To quote the applicate - Little Clacton is categorised as a 'Rural Service Centre' in the settlement hierarchy contained within Policy SPL1 of the TDLP (2022). The supporting text reads,'For these settlements, the Local Plan identifies opportunities for smaller-scale growth. Some of these villages will accommodate a modest increase in housing stock, where appropriate, within the plan period...These developments will make a meaningful contribution toward addressing local housing needs, supporting the village economy and assisting with the overall housing growth proposed for the District'

The village of Little Clacton has approved dwellings to be built in the hundreds, over and above a modest increase and does not require any more to meet any variation of 'numbers'. To name but a few sites – 98 -The Street, 30 - Land to rear of 59 & 61 London Road, 10 - 24 The Street, 81 – Chicken Farm, 21 - Crossways Recommend Refusal

23/00365/FUL -Proposed erection of 58 no. dwellings (including 18 Affordable Dwellings) complete with estate roads, public open space and garaging.

Land South of Holland Road CO16 9QH

This site falls within the settlement boundary and connects with applications already approved for numerous dwellings. As with all the applications for this extended area of development we have huge concerns for the bottleneck access and huge increase of vehicle movements with no road upgrades or traffic calming measures. We would look for an agreement to be in place for monies towards highway improvements/ maintenance as part of the agreement. As a Parish council we would like involvement in the allocation of any \$106 funds before agreed with TDC.
