22/02098/FUL - 58 - 62 The Street CO16 9LG

Proposed demolition of No. 58-62 and redevelopment of the site for 11 no. market dwellings (net increase of 9). (Changes made to original application 15/12/2022) Resubmit the original comments of the 07 Feb 2023, along with additional information.

This site is unsuitable and totally unneeded for this application for additional large multiple properties. The site is accessed by a narrow width road which joins the highway at a dangerous and busy turning point. Residents have already complained to the parish council about vehicles parking and lack of visibility all around the only access junction. The size of the properties (1*2 bed, 5*3 bed, 2*4 bed + 3*5 bed) raised concerns not only for additional traffic flow but also the amount of parking for the households. As a mini estate the only visitors parking would be in the dead end road or within the car park servicing the animal rescue facility.

This site is not with the accepted Local plan and the village has already been overwhelmed by the constructions of new dwellings within the last few years. (Multiple mini estates including Stone Hall, Harwich road, Holland Road, The Street) The Parish has large developments approved yet to be built - 96 homes on the Street, mini estate at Hayes garage etc)

We as a Parish have already provided enough of the 'numbers' required by the Council for new dwellings and find no requirement for this contribution to numbers. Since the original application the approval of application 23/00999/FUL (Brays DIY 54 The Street CO16 9LF) needs to be taken into account. This site is adjacent to the turning/long driveway of this application meaning an increase of vehicles at this precarious location. Along with the high frequency bus stop opposite this opening, we feel it will be too dangerous a location to add more housing exiting at the same location. 23/01471/LBC - Reedlands Cottage Holland Road CO16 9RX Proposed re-pointing of the two inglenook fireplaces, raking out the existing grey cement mortar and re-pointing with traditional lime mortar. Replace approximately thirty isolated bricks using reclaimed soft clay Tudor or Imperial soft red bricks
